PRISONER HOUSING AGREEMENT
CHARLES MIX COUNTY LAW ENFORCEMENT CENTER
LAKE ANDES, SD

IT IS HEREBY AGREED by the Board of Charles Mix County Commissioners and the Board of **MINER COUNTY COMMISSIONERS** that the Charles Mix County Law Enforcement Center will house and feed prisoners for **MINER COUNTY** at the following rate:

\$100.00 each prisoner each day

IT IS FURTHER AGREED that **MINER COUNTY** will be responsible for all medical expenses, including but not limited to prescription medications, clinic visits, hospital visits and ambulatory transportation.

IT IS FURTHER AGREED that **MINER COUNTY** agrees that when Charles Mix County Sheriff's Office/Jail does any type of transport or needs extra guarding of **MINER COUNTY** prisoners there will be a charge of \$60 per hour (this includes mileage).

IT IS FURTHER UNDERSTOOD that the above daily rate is subject to an increase, at which time notification will be forwarded.

IF IS FURTHER AGREED that when **MINER COUNTY** prisoners or detainees are brought to the Charles Mix County Law Enforcement Center by **MINER COUNTY** Law Enforcement Officers, that said Officer shall inform Charles Mix County Law Enforcement jail personnel of any special physical or psychological problems(s) of said prisoner(s), including suicidal tendencies, and that failure to so inform Charles Mix County Law Enforcement Center personnel may result in liability for **MINER COUNTY**.

Charles Mix County and its Sheriff and his Deputies and personnel reserve the right to refuse to receive any prisoner(s) or detainee(s) at the Charles Mix County Law Enforcement Center because of medical or psychological problems, including possible suicidal risks, and that such refusal shall not be deemed a breach of this Agreement.

IN ADDITION, Charles Mix County may refuse access to **MINER COUNTY** and its prisoners due to lack of space for said prisoners.
